Terms and Conditions

- What to bring:** All students are advised to bring a back-pack, water bottle, 2 Pencils & Erasers, Extra change of clothes, Lunch, 2 healthy snacks & a drink.
- Peanut Free Environment:** Since some students might be allergic to nuts, the lunch and snack should be nut free.
- Pick up and Drop off:** Drop off at 9am, pickup at 3pm. As a courtesy, parents can drop off the children at 8am and pick them up by 4pm. **A \$1 fee will be charged for every minute late after a 15 minute courtesy wait.**
- In case of a medical emergency, the parent/legal guardian that has signed on page 1 of this registration form authorizes any physician, nurse practitioner or medical personnel to examine, interview, test and if necessary, treat the participant/participants listed on page 1 of the registration form.
- The parent/legal guardian give permission to Gras Summer Club and GRAS Child Development and Educational Association to photograph and/or videotape the student for educational and promotional purposes.
- The parent/legal guardian understands that certain indoor, outdoor and sports activities associated with an outdoor camp activity have an inherent risk factor, and that all appropriate precautions will be taken for the safety of my child. However, in the event that the child is injured, the parent/legal guardian will not hold GRAS Child Development and Educational Association, Gras Summer Club organizers, camp counsellors or volunteers responsible for such incidents.
